### **2022 Estimated Capital Gain and Income Distributions**

To assist you with your tax planning, Boston Partners Investment Funds is providing you with advanced notice of estimated capital gain distributions, annual income distributions and certain calendar year-end income distributions (as applicable) that are associated with your investments in certain Boston Partners Investment funds(s). These estimates are as of September 30, 2022.

Although this information is preliminary and subject to change, we believe it may be helpful to provide you with the estimated distribution information on your funds as early as possible before calendar year end. Having these early estimates available should give you an opportunity to evaluate your potential tax liability with your financial professional and/or tax adviser and make adjustments to your account(s), if necessary.

Please take note that the estimated capital gains and income distributions outlined on the following page are for all share classes underlying a particular Fund strategy.

In November and December 2022, we will be paying out all required accumulated capital gains. However, we cannot rule out the possibility of a second, smaller distribution at year end, depending on each fund's activity and market conditions at that time. Final amounts will be available on each fund's ex-dividend date. However, you should wait until you receive your Form 1099-DIV from Boston Partners Investment Funds before calculating your taxes. These forms are expected to be mailed in early 2023.

We will be updating the estimates with 10/31/22 numbers when available. Please note that these are ESTIMATES ONLY and subject to change.
